



## Customer Limited Warranty Schedule for New Products

**General Provisions.** This warranty shall apply to the original purchaser of (1) any new and unused machine manufactured by Mac Company, LLC, and (2) any new and unused part which is manufactured by Mac Company for use in a Mac Company machine, jointly referred to as “Products” whether such Product is purchased through a dealer or directly from Mac Company. Under this Warranty, Mac Company will repair or replace, as it chooses in its sole discretion, any covered Product, or any component thereof, which Mac Company determines to be defective. The Warranty Period for all coverage begins at the time that any person, dealer or agent first places the unit into service referred to as “Warranty Start Date”. At the latest, a unit is considered to be placed into service when purchased or delivered to an initial retail purchaser. This warranty period shall be in effect for:

The purchaser must pay the cost of transportation of a Product to be repaired or replaced to and from Mac Company or a Mac Company authorized dealer. This Warranty does not give a purchaser the right to any relief other than repair or replacement of the Product, and it specifically does not allow for consequential or incidental damages, exemplary or punitive damages, or costs or fees.

**Scope and Limitations of Warranty.** With respect to machines, this Warranty is void if any part not supplied by Mac Company is used in assembly or repair of the machine, or if the machine has been altered, abused or neglected, as determined by Mac Company. This Warranty does not extend in any way to tires and any other component or a Product warranted by another manufacturer (“Third-Party Warranties”). In the event Mac Company determines that a Product is not defective, or that any other provisions of this Paragraph 2 operate to limit the Warranty, this Warranty shall not apply, and the purchaser shall be responsible for transporting the Product from the authorized Mac Dealer’s location within 10 days of notice by Mac Company.

**Procedure for Obtaining Service.** To secure Warranty service, a purchaser must (1) report the defect to Mac Company or an authorized dealer and request repair within 15 days of the failure and within the Warranty Period; (2) present evidence that this Warranty applies to the Product; (3) present evidence of the Warranty Start Date; and (4) bring the Product to an authorized Mac Company dealer within a reasonable period of time after reporting the defect.

**Limitation of Implied Warranties and other Remedies.** To the extent allowed by law, neither Mac Company, its dealers, nor any company affiliated with Mac Company makes any warranties, representations, or promises as to the quality, performance, or freedom from defect of any Product covered by this Warranty.
